

Harbourfront Centre Camps Subsidy Package 2022

Thank you for your interest in the Harbourfront Centre Camps Subsidy program! This subsidy program is designed to assist families whose financial circumstances make it difficult to afford a camp experience for their children. Financial assistance is available for up to **two weeks** during the summer. Limited space is available. As the aim of the program is to provide as many children as possible with this valuable camp experience priority will be given to applicants who have not received financial assistance in the past.

DEADLINES

Summer Camps: Applications for subsidies must be received by 4pm (ET), May 27, 2022.

Please note: All Kids First applicants must submit a complete application to be considered. Applications are processed as they are received. Spaces are limited and based on availability.

QUALIFYING FOR SUBSIDY

We are able to subsidize up to 100% of the camp registration fees, with some exceptions. We are unable to offer subsidy on travel. Some camps have restrictions on the amount of subsidy that can be awarded. Should the subsidy be provided by a third party, you may be asked to provide additional information in the form of a testimonial or other documentation. If this is a condition of your subsidy being provided, you will be informed of it at the time of your registration.

Subsidy rates at Harbourfront Centre are geared to the Low Income Cut-Off (LICO) as determined by Statistics Canada. This criterion is calculated annually and will always use the most updated LICO as the base line. The amount of discount provided is linked to the **before tax** income as determined by the LICO.

Once your application has been received and processed, you will receive an email confirming receipt of application. If your application has been approved, please contact the Camps Office immediately to provide payment details. **Registrations are not complete until payment information has been provided.**

APPLICATION PROCESSING

Applications are assessed on a first come, first served basis. You will be notified **by email** about your application within 5 business days. If your application is accepted, you must contact the Camps Office to provide payment details.

Should you wish to secure your desired camp and session, we recommend that you register online in advance (this does not affect the decision regarding your subsidy application). If you register online beforehand you will be required to make online payments to secure your spot. If approved, your subsidy will be applied to your online registration and refunds will be processed, or monthly payments adjusted as necessary.

Should your application for financial assistance be denied, you will be notified **by e-mail**. If you have registered online prior to your assessment, you can cancel your registration with a full refund and no cancellation fee, or you can keep your registration and pay full price. You are responsible for informing the Camps Office regarding your decision within **5 business days** of the receipt of your denial, or your registration will be confirmed and subject to our published registration policies.
